Participants earn vouchers by attending classes, doing homework, etc. and are able to use their vouchers to purchase baby items in the Mommy Store. Classes are offered on topics such as nutrition, breast feeding, infant care, Bible study and sexual integrity.

4c (Code:) (Expenses \$ 74,414 including grants of \$) (Revenue \$) Client Advocacy Program (CAP) Peer counseling and free pregnancy tests, offering women information, referrals and emotional and spirtual support to help them cope with their pregnancy. Information is offered regarding fetal development, abortion and its risks, adoption and help available from both our program and those of other helping agencies. We ask permission to contact them after their visit so we can continue to express our concern for them and offer our help
